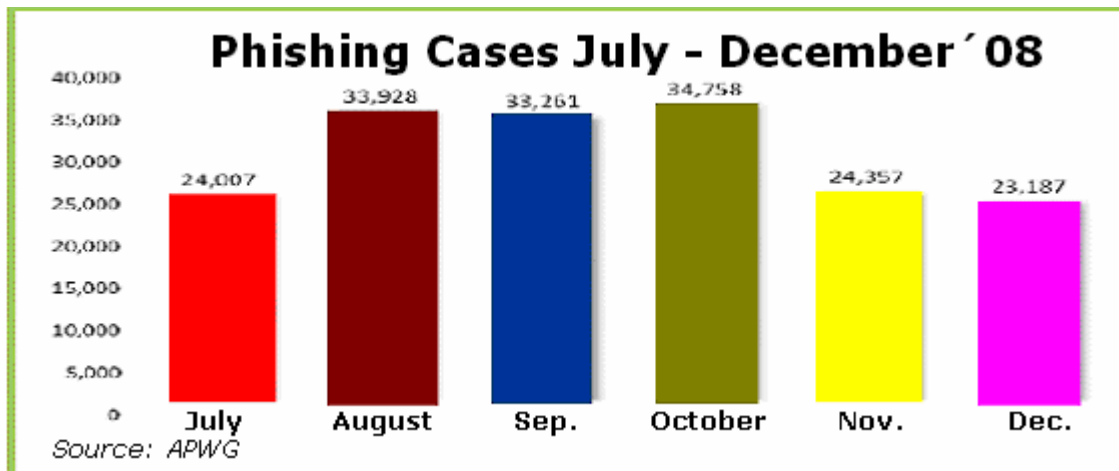

1. What's NicLine's Whois Privacy Service - WPS?

Today ICANN regulations require all data from domain Holders to remain visible through the Public Whois in an effort to maintain a publicly accessible database by displaying all contact information for every single domain name registered over the Internet. Failure to provide such accurate information could result in the deletion of the domain name from the Registry.

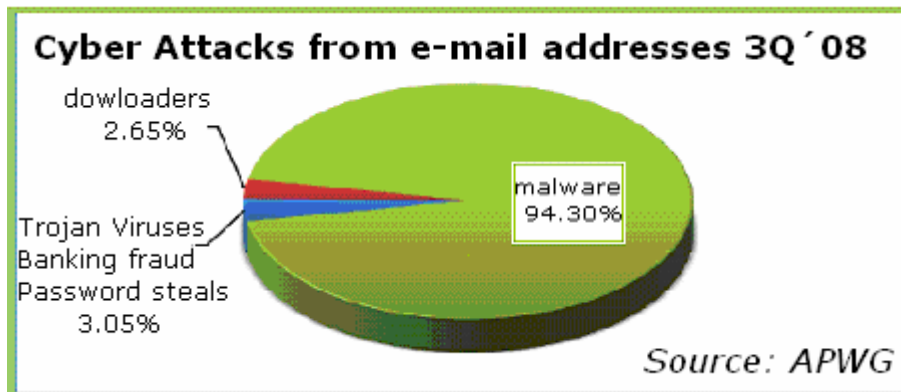
Nonetheless, exposing personal information poses serious security issues. Whenever you register a domain name, your personal contact information such as your e-mail address or your phone number are automatically made available 24/7 to everyone everywhere through the Public Whois Database. In the following chart, APWG shows all phishing cases registered from July 2008 to December 2008 because of data seen or taken from the Public Whois Database:



NicLine's Whois Privacy service provides an Identity Protection Service to conceal Holder data and any contact data associated to a given domain while complying fully with ICANN Rules and Regulations. NicLine's WPS will let you conceal your private contact information which will not be exposed on the Internet and remain anonymous. Concealing your domain Holder personal data will prevent you from becoming a victim of cybercrime shielding you from spammers, identity theft, cyberfraud, data mining, spoofers and hackers.



To protect users from these illegal practices, NicLine's WPS incorporates one email redirection dynamic system so that a random email address, such as abc1234567grds@whois-privacy-service.net generated from a domain name created to keep the WPS running, will automatically redirect the email received to the Holder's or Contact's real email address. Find below two charts showing cyber attacks committed against real email addresses from domain Holders during the third quarter of 2008.

- **Whois Privacy** - Hire Term: 1 – 10 years

This version includes the email redirection dynamic system to the client's real email address. Whois Privacy service version conceals all records **but** the Holder's real name. See chart below.





























































Hire the Whois Privacy service version with the following domain extensions only: .com, .net, .org, .info, .biz, .ws, .mobi, .cat, .tv, .cc, .es, .com.es, .nom.es, and .org.es. Also available for IDNs when applicable to these extensions.



- **Whois Privacy Complete** - Hire Term: 1 – 10 years

This version includes the email redirection dynamic system to the client's real email address. Whois Privacy Complete service version conceals all records including the Holder's name. See chart below.

Hire the Whois Privacy Complete service with the following domain extensions only: .com, .net, .org, .info, .biz, .ws, .mobi, .tv and .cc. Also available for IDNs when applicable to these extensions.

2. How can I hire the WPS?

Since the WPS is associated to a domain name hiring the WPS will always depend on the existence of a given domain, any given registrar transfer or even the creation of a new domain. Yet the WPS will not be associated to domains in the expired status and expired-hold status whatsoever. Find the way to hire NicLine´s Whois Privacy service:

1.- When Registering Domains for the first time:

* Go to the Wholesaler Extranet>> Click on Domains>> Register or use the CGIRegistrar.asp script if you got NicLine´s API already running.

2.- When Requesting Registrar Changes:

* Go to the Wholesaler Extranet>> Click on Domains>> Transfer or use the CGICambioRegistrador.asp script if you got NicLine´s API already running.

3.- When Editing Data from a domain name:

* Go to the Wholesaler Extranet>> Click on Domains>> Modify or use the CGIModificarDominio.asp script if you got NicLine´s API already running.

3. How much is it?

NicLine´s Whois Privacy service can be hired from one (1) to ten (10) years only. Also if the WPS is activated for a domain name that is already been registered the WPS billing/payment date (day & month) will match the domain expiration date.

NicLine´s Whois Privacy service will be paid in U.S. dollars. Indicative price however will be set in Euros and based on the daily USD/Eur rate. Find our pricelist below:

4. What if I need to make my domain data visible for a short period of time?

You can deactivate the WPS to make your domain data visible in the Public Whois Database for a short period of time if you wish to show who the Holder of a domain really is. After deactivating the WPS you can conceal all data back again. These activation/desactivation operations can be performed from the Wholesaler Extranet or the API.

5. I got NicLine´s API implemented for domain management but can I use it to hire the WPS?

Yes, you can. You can hire NicLine´s Whois Privacy service by calling five scripts from our API: CGIRegistro.asp, CGICambioRegistrador, CGIModificarDominio, CGIRenovardominio and Changedomain.asp.
